Subject: Government

Topic: Separation of Powers

Sub-topic: Meaning, Importance, and Arms of Government

1. Lesson Objectives (By the end of the lesson, students should be able to):

- Define the term Separation of Powers.
- Identify and describe the three arms of government.
- State at least three importance or advantages of separation of powers.
- Explain what happens when powers are not separated in a government.

2. Previous Knowledge

Students already know the **functions of government** and the **structure of a state** from earlier topics.

3. Set Induction (5 minutes)

Teacher's Action:

Writes these three words on the board: Legislature, Executive, Judiciary.

Then asks:

"Imagine if one person made the laws, enforced them, and judged people. What could go wrong?"

Expected Student Response:

- "It would be unfair."
- "There would be abuse of power."
- "Nobody would check the person."

Teacher's Link:

"Exactly. That's why modern governments follow something called **Separation of Powers**, which we'll learn about today."

5. Instructional Techniques

- Explanation
- Question and Answer

6. Lesson Presentation Steps

Step 1: Introduction to Separation of Powers (10 minutes)

Teacher Explains:

- Separation of Powers is a system where the functions of government are divided among **three distinct arms**.
- These arms work independently and act as checks on one another to prevent **tyranny or dictatorship**.

Definition:

"Separation of powers means dividing government responsibilities into different branches to limit any one branch from exercising the core functions of another."

Step 2: Description of the Arms of Government (10 minutes)

Arm Function

Legislature Makes laws

Executive Implements laws

Interprets laws and settles disputes

Judiciary

Teacher's Action:

Draws a simple triangle on the board to show how each arm relates to the other. Emphasizes their independence and interdependence.

Step 3: Importance of Separation of Powers (10 minutes)

Teacher Highlights:

- Prevents abuse of power
- Promotes fairness and accountability
- Encourages rule of law
- Each arm checks the other, creating balance
- Protects individual rights

Example:

"In Nigeria, the National Assembly cannot arrest citizens—that's the job of the police, under the Executive."

Step 4: Class Interaction and Guided Practice (5 minutes)

Ask:

- "Which arm of government signs a bill into law?" → Executive
- "Who decides if a law is unconstitutional?" → Judiciary
- "Who can impeach a president?" \rightarrow Legislature

7. Evaluation (5 minutes)

Ask students the following questions:

- 1. What is separation of powers?
- 2. Mention the three arms of government.
- 3. State two functions of the legislature.
- 4. Why is separation of powers important?
- 5. What might happen if one person controls all three arms?

Assessment Type: Oral Questions + Brief written guiz

8. Summary/Conclusion (2 minutes)

Teacher Recap:

- "Today, we learned that a country's government must divide power among the legislature, executive, and judiciary."
- "This system helps prevent misuse of power and promotes justice."

9. Assignment

Instruction:

In your Government note, answer the following:

- 1. Define separation of powers in your own words.
- 2. Draw and label a diagram showing the three arms of government and their roles.
- 3. Give one real-life example of separation of powers in Nigeria.

Note:

The timing might not be necessary.
